

LHV Website Terms of Use

1. General information

- 1.1. The LHV website terms of use (hereinafter **User Terms**) apply to this website and its subpages (hereinafter **Website**) which belong to AS LHV Pank (hereinafter **LHV**).
- 1.2. By accessing and using the Website, the user represents and warrants that he/she has examined the User Terms, understood them and fully accepted them. In the event of conflict between the User Terms and the terms and conditions of specific products and services, the latter shall prevail.

2. Information available on the Website

The other type of cookies, so-called session cookies, are stored only temporarily for the time the user accesses the site.
- 7.3 LHV uses cookies to improve the quality of the statistical data collected about the users and to enhance the functionality of the Website.
